GUIDELINES TO AUTHORS

TYPES OF ARTICLES

Types of articles for publication include: 1) original articles, 2) short reports which include brief technical notes and preliminary communications that should not be more than 750 words, 3) reviews normally by invitation, 4) case reports and 5) letters to the editor arising from papers previously published in the journal which should be less than 400 words.

PREPARATION OF MANUSCRIPTS

General Requirements

A. The manuscript should be typed double spaced on one side of A4 size paper with 3cm margins. All pages should be numbered.

B. It should contain the following headings: – Title page, Abstract (except for short reports, reviews, case reports, letters to the editor, book review), Text, References, Figure legends, Tables and Figures.

Specific Requirements

A. Title page: – should contain the title of the work, author's names, institute(s) in which the work was carried out and also name, address / telefax numbers and email address for correspondence.

B. Abstract: – should outline the aim of the study, methods, results, discussions and conclusions of the work under separate headings. It should contain no more than 200 words. Up to 5 key words should be provided at the bottom of the abstract.

C. Text: – should contain the following sections – introduction, materials and methods, results, discussion and acknowledgement.

D. References: – citations for the reference section of submitted works must be numbered consecutively. In the text, references should be cited in number. Include names and initials of all authors (if more than six authors, then only the first three names followed by et al.)

Examples

1. Mamo JCL, Lian L, James AP et al. Plasma lipoprotein β -amyloid in subjects with Alzheimer's disease or mild cognitive impairment. *Ann Clin Biochem* 2008, 45: 395-403
2. Young DS, Bermes EW. Preanalytical variables and biological variation. In: Burtis CA, Ashwood ER, Bruns DE (eds) *Tietz Textbook of Clinical Chemistry and Molecular Diagnostics*. Elsevier Publisher, St. Louis. 2006: 449-473
3. Baynes JW, Dominiczak MH. *Medical Biochemistry*. (2nd ed.)

Personal communications should be avoided. Manuscript in preparation or submitted, but not yet accepted, should not be included in the list of references.

E. Tables: – should contain a descriptive heading, numbered with Arabic numerals and printed on a separate sheet.

Figures: – should be referred to in the text as 'Figure' and given Arabic numerals. Except for photographs, all figures should be in black/grey/white colour e.g. line graphs and histograms should use patterned lines or boxes to differentiate between groups of data.

G. Units: – All measurements should be expressed in SI units.

SUBMISSION OF MANUSCRIPTS

Please submit manuscripts and related documents to the Editor in Chief via email only (mjcb.editor@gmail.com).

The corresponding author should also submit a cover letter stating that 1) all authors contributed significantly to the work reported in the manuscript, 2) all authors have declared any conflicts of interest and 3) the manuscript has not been published previously or is currently submitted elsewhere for publication. Please email a copy of the cover letter, signed on behalf of all authors, together with the manuscript.

Articles are accepted for publication on the understanding that, in consideration of acceptance, the entire copyright shall pass to the Malaysian Journal of Clinical Biochemistry.
