#### 2.0 SCIENTIFIC SUBCOMMITTEE REPORT

(by Y.M. Raja Dr Elina Aziddin, Chairman of Scientific Subcommittee)

Just like many countries around the world, Malaysia is not spared from the Covid-19 pandemic. On 18<sup>th</sup> March 2020, the Malaysian government declared a nationwide movement control order to control the increasing number of Covid-19 positive cases in the country. Restrictions to mass gatherings impacted many of the planned activities of the MACB for 2020. The 30<sup>th</sup> MACB conference scheduled to be held in July 2020 had to be postponed. However, the Scientific Committee decided to carry on its activities by going virtual. To date, the committee has organized 3 webinars and will host another webinar in early December 2020. The 30<sup>th</sup> MACB Conference will also be virtual.

# 2.1 MACB Webinars

In line with its main objective, the MACB launched a series of webinars to ensure continuous education and learning of clinical laboratory professionals during the Covid-19 pandemic. With the support of our corporate partners, all webinars were made available to MACB members and the clinical laboratory community locally and abroad at no cost.

### 2.1.1 The Power of Laboratory Medicine to Achieve Measurable Better Healthcare

This webinar on the title of *The Power of Laboratory Medicine to Achieve Measurable Better Healthcare* was held on 4<sup>th</sup> September 2020. The objective of the webinar was to create awareness for the UNIVANTS of Healthcare Excellence Award and to promote collaboration across disciplines. The MACB hopes that the webinar will be able to inspire member countries in the Asia Pacific region

to push beyond convention and transform care delivery through teamwork, novel thinking and insights associated with laboratory medicine that will have positive effects on clinicians and patients.

This webinar received the auspices of the APFCB and was supported by Abbott Diagnostics.

Lectures in this webinar were delivered by 3 speakers. The first lecture on the topic of *Unifying for Something Greater: The Univants of Healthcare Excellence Program* was delivered by Tricia Ravalico. The second lecture was delivered by Dr. Eleanor Dow on the topic of *Intelligent Liver Function Testing (ILFT): A Cost-Effective Way to Increase Early Diagnosis of Liver Disease while* the third lecture was delivered by Dr. Marthias Orth on the topic of *Avoiding Insufficient Therapies and Overdosing with Co-Reporting e-GFRs for Personalized Drug Therapy and Improved Outcomes.* 

This webinar had 123 participants; 58% were from Malaysia - 74, 23% from Singapore- 27 and the rest were from China- 1, Germany- 2, South Korea- 1 Thailand- 5, India- 4, Indonesia- 5, Sri Lanka- 1, United State- 2 and Vietnam- 1.









#### 2.1.2 <u>Tube Verification and Validation Webinar Series</u>

The Tube Verification and Validation webinar series is a 3-part webinar, organised to shed light to important questions such as: the regulatory guidelines for blood collection tube selection and validation, how to design a validation protocol and the variables that should be considered during verification to ensure adequate performance in clinical use. This webinar series is supported by Becton Dickinson.

The first part of the webinar was held on 18<sup>th</sup> September 2020 on the topic of *The Science Behind Blood Collection Tube and Tube Validation*. The lecture was delivered by Dr. Puneeta Bhatia. This webinar received an overwhelming response where a total of 962 people registered. Of this number, 402 were live viewers of the webinar (37%) where Malaysians accounted for 126 participants, Philippines – 102, Indonesia – 82, Singapore – 49 and others (Australia, India, UAE, etc.) – 43.



The second part of this webinar series was held on  $16^{th}$  October 2020. Mr Brian Smith delivered the lecture on the topic of *Tube Verification Protocol Design*. A total of 673 people registered. There were 279 live viewers of the webinar (41.5%; an increase of 4.5% from the first webinar) of which Malaysians accounted for 116 participants, Philippines – 77, Indonesia – 61, Singapore – 20 and other (Australia, India, UAE, etc.) – 5.

The third part of the webinar series is on the topic of *Blood Collection Tube Verification: What Your Text Book Do Not Teach You*, will be held on 4<sup>th</sup> December 2020 and will be delivered by Kala Devi Nadarajan.

#### 2.2 30<sup>th</sup> MACB Conference 2020

The 30th MACB Conference 2020 will be a Virtual Conference and will held on 26th-28th November 2020. This two- and half-day event will feature lectures on various topics of interest and will be aired live or pre-recorded with live Q and A. Due to the generous support of our corporate sponsors, the MACB Virtual conference will be made available to members and the clinical laboratory community. Details the conference is available locally and abroad at no cost. on https://conference.macb.org.my/.

#### 3.0 EDUCATION SUBCOMMITTEE REPORT

(by Y.M. Tunku Marinah, Chairman of Education Subcommittee)

# 3.1 Skills Training for Clinical Biochemists

The preparation for skills training included registration of MACB as a training centre and Hospital Kuala Lumpur and Pantai Premier Pathology as partners for practical sessions. There are many committees working on various aspects and to coordinate them a Working Committee for NOSS was established early 2020 and comprise 3 biochemists namely Rusli Ibrahim, Nik Awatif Kamil dan Rohaznida Baharuddin.

The Working Committee first meeting was held on 6 Feb 2020 at MACB office, KL. The second meeting was planned for 3<sup>rd</sup> quarter of 2020 but due to Covid-19 was postponed.

#### Some issues:

- a. Hospital Kuala Lumpur (HKL).
  - Pengurus HKL, Dr Safini was unsuccessful to get place in SLDN training course on 12.3.2020. Her plan to attend the same course on 16.6.2020 could not be achieved as the course was cancelled due to Covid-19 pandemic.
- b. Pantai Premier Pathology (PPP).
  - Pengurus at PPP was ready. 5 topics for research projects are ready but powerpoint for that proposals were in progress.
- c. Lecturer for NOSS Programme
  - To date, all modules have sufficient applications for lecturers.

### 3.2 Workshop and Webinars

One workshop was held in January. Due to Covid-19 and the Movement Control Order (MCO) imposed in the country, all activities after March were put on hold until we made decisions for alternative ways to do training activities. It was agreed by the Council that we should conduct all activities via online webinars, but since MACB had no experience at all in doing this, the corporate sector was contacted to get their involvement. Several companies came out to support us, gave their suggestions and shared their experiences on this. Under the Education Subcommittee, two webinars were conducted.

# 3.2.1 IFCC-MACB Advanced Molecular Biology Workshop

This advanced workshop was organized by the Malaysian Association of Clinical Biochemists (MACB) in collaboration with the International Federation of Clinical Chemistry and Laboratory Medicine (IFCC). It was supported by Universiti Kebangsaan Malaysia (UKM).

It was held on 29-31 January 2020 at the Seminar Room Blok D, UKM, Jalan Raja Muda Abdul Aziz, Kuala Lumpur.

The workshop was carried out in 3 parts over the 3 days:

- A. Infectious Diseases & Hereditary Introduction to Molecular Biology, Quality Assurance, Validation of tests, Hereditary Disorders, Medical Reporting.
- B. Oncology (Tissue & CTCs) Treatment of cancer patients, Principle of NGS, Libraries, Data analysis, QC, Validation of data, CTCs.

C. CNAPS - ctDNA, NIPT.

It was planned to have 4 speakers but unfortunately at the last minute, Dr. Liandou who organised everything at IFCC's end, could not attend as she was sick. Speakers:

- 3. Verena HASELMANN, MD, Department: Institute for Clinical Chemistry, University Medicine Mannheim, Medical Faculty Mannheim of the University of Heidelberg, Germany
- 4. Ettore Capoluongo, Professor of Clinical Biochemistry and Clinical Molecular at Catholic University of Rome, Head of Department of Laboratory Medicine and Molecular Genetics at Research Hospital IDI, Rome, Italy

In all it was a very fruitful and educational workshop. There were 32 registered participants and 4 members of the MACB organising committee also attended.

### 3.2.2 Webinar on Role of the Laboratory in the Battle Against Covid-19 Report

The MACB organized its first live webinar on 26<sup>th</sup> Aug 2020 on the topic of *Laboratory Role in the Battle Against Covid-19*. This webinar focused on experiences of Malaysian laboratories involved in the testing of Covid-19 patients during the current Covid-19 pandemic with the hope that the sharing of experiences will be of benefit to all laboratories during these difficult times.

This webinar was supported by our corporate partner Roche Diagnostics (M) Sdn. Bhd. Lectures were delivered by 4 local speakers: Dr. Tuan Suhaila on the topic of *Molecular Testing of Covid-19: Sungai Buloh Experience*, Dr. Donul Huda on Serology Testing for Covid-19, Dr. Sharifah Khairul Atikah dan Dr. Firdaus on The Importance of Supporting Tests in the Management of Covid-19 Patients.

The 206 participants who registered for this webinar were mainly from Malaysia while others were from Indonesia-15, Nepal-2 and Japan-1. Despite some hiccups and technical problems during the live session, the recorded version was quickly uploaded on the MACB website and can be viewed on the MACB website (<a href="www.webinar.macb.org.my">www.webinar.macb.org.my</a>). Overall, the webinar received a positive feedback from participants.

# 3.2.3 Webinar on Myocardial Injury in the Era of High Sensitivity Troponin

The latest generation of high-sensitivity cardiac troponins support rapid diagnostic protocols aiding in the earlier discharge of a significant percentage of non-AMI patients, as well as aid a faster admission. The webinar, held on 9<sup>th</sup> September 2020 discussed the latest updates in the guidelines related to high sensitivity troponins and their clinical utility within Asia Pacific.

This webinar was delivered by Dr. Pearline Teo of Siemens Healthineers, Singapore and was supported by Siemens Healthineers. The event was moderated by Dr. Farhi Ain of UMMC who was a very professional and natural moderator. Leo Selvaraj and his team set up the system at MACB office while another team was assisting Dr. Ain.

There were 136 registrations while a total of about 75 participants dialled in from Malaysia and Singapore. The feedback received from attendees for the webinar were generally positive. One said that the topic was "very relevant to job scope" while another stated that it was "useful" and "informative". Many also requested for more webinars to be organized on more specific topics relating to best practices on high-sensitivity cardiac troponin implementation.
