2.0 SCIENTIFIC SUBCOMMITTEE REPORT

(by Y.M. Raja Dr Elina Aziddin, Chairman of Scientific Subcommittee)

In Malaysia, the rate of Covid-19 positive cases has been steadily increasing since January 2021 and reached a peak in early August. With the high rate of vaccination in the country, the number of positive cases is seeing a downward trend; but to date, the country is still battling hard with the pandemic.

Due to the current situation, all MACB activities in 2021 have been conducted via the virtual platform.

2.1 30th MACB Conference 2020

The Covid-19 pandemic caused disruptions to the scheduled activities of the MACB due to restrictions imposed under the movement control order. The 30th Annual Conference of the Malaysian Association of Clinical Biochemists which was planned to be held in August was instead successfully organized for the first time as a virtual event. The MACB Virtual Conference 2020 took place between the 26th to 28th November 2020.




Fig 1: MACB Virtual Conference 2020 website

This Conference carried the theme '*Innovative Solutions: The Way Froward in Laboratory Medicine*". This theme was chosen as medical laboratories today are faced with many challenges such as rising cost, limited manpower and high public expectation; made worse with the onset of the pandemic. Innovation is a strategic change that creates value. It can provide medical laboratories with the opportunity to overcome current and future challenges.

The conference featured 16 lectures. An interesting lecture on the topic of *"The Future of Laboratory Medicine: The Impact of Exponential Technologies & Platform Economy"* illustrated how exponential technologies such as artificial intelligence (AI), cloud computing, augmented reality (AR), and virtual reality coupled with cheaper and faster internet availability have transformed organisations to create value, manage their operations and their talent. The lecture described how the future of healthcare is related to key trends namely power of data, flexible organization and the focus on prevention and wellness. It also discussed the risks and possibilities of how trends set by leading platform-based business models can permeate and transform the medical laboratory sector.




Fig 2: Lecture on "The Future of Laboratory Medicine: The Impact of Exponential Technologies & Platform Economy"

Focussed topics related to the Covid-19 pandemic were delivered in two lectures entitled "*The Value of Sars-Cov-2 Serology Testing and Implications for Vaccine Evaluation*" and the lecture on "*Applying Health Systems Principles and Economic Analysis towards a Pandemic-Resilient Lab Service*" which discussed how lab services fit into health systems framework and how Covid-19 pandemic can accelerate the implementation of next-generation lab services.

The program also addressed other topics of interest such as "Epidemiology and Diagnosis of Nasopharyngeal", "Clinical Use of High-sensitivity Troponin at the Point-of-Care with ESC 1-hour Algorithm", "The Role of the Laboratory in Meeting the Asian Pacific Society of Nephrology Clinical Practice Guideline on Diabetic Kidney Disease", "Addressing the Emerging "Epidemic" of Fatty Liver Disease", "PTH: Keeping Up with the Generations", "Clinical Application of MU", "The QC Standards, Past and Present: Novel Controversies and Old Struggles", "Sigma Metric – Quality Framework of Point of Care Glucose Testing". "Auto-verification of Lab Results", "Strategies in Overcoming the Frequent Errors in STAT Laboratory", "ISO 15189 Accreditation – Remote Assessment", "Licensing of Medical Laboratory Science Personnel and the Impact on the Medical Laboratory Service". Lectures were delivered by experts from Malaysia, United States, Australia and Hong Kong. The APFCB Travelling Lecture was delivered by Helen Martin from Australia on the topic "Adding Value with Patient Report Commenting". Lectures were followed by live question and answer session.

Despite the very short notice, the conference received generous support from the corporate sector namely Snibe, Siemens Healthineers Malaysia, Radiometer Malaysia Sdn Bhd, Acutest Systems (M) Sdn Bhd, AxisBio Diagnostics Sdn Bhd, Becton Dickinson Sdn Bhd, Chemopharm Sdn Bhd, Medinics (M) Sdn Bhd, Roche (Malaysia) Sdn Bhd and Utas Maju Sdn Bhd. The conference was made available to participants at no charge. A total of 1173 participants from 23 countries registered for the event.

2.2 Asian Conference on Biomedical Research & Lab Medicine (ACBRLM) 2021

ACBRLM 2021 was jointly organized by three associations; the Malaysian Association of Clinical Biochemists (MACB), the Malaysian Biomedical Science Association (MyBiomed) and the Association of Scientific Officers Ministry of Health (ASOMH). ACBRLM 2021 is the first joint collaboration among the three organizations. ACBRLM 2020 was initially scheduled for August 2020, but was postponed due to the COVID 19 global pandemic.

This conference was conducted on 24th-25th August 2021 with a post conference workshop on 26th August 2021. The conference and workshop were conducted virtually.

The conference which carried the official theme "Revolutionizing Laboratory Medicine Through Research and Innovation" covered topics which revolved around communicable and non-communicable diseases, genetics and molecular diseases, drugs and natural product discoveries, latest technology, methods and sharing of research findings. The conference was officially launched by the Director of Health, Malaysia. The two-day conference, with two concurrent sessions featured one keynote speech, two plenary lectures and 16 symposia lectures. In the post-conference workshop seven interesting topics in laboratory medicine were presented.

The participants of ACBRLM were from continent of Asia and comprise of laboratory scientists, pathologists and various other categories of laboratory professionals. More than 400 participants attended the conference and among them there were 70 posters and 22 oral contributors who shared their experiences and knowledge in their respective fields. The conference was sponsored by Perkin Elmer Sdn Bhd, Abbott Laboratories (M) Sdn Bhd, Utas Maju Sdn Bhd, Siemens Healthineers Malaysia, Chemopharm Sdn Bhd, Roche (Malaysia) Sdn Bhd, QuantumG, Agilent Technologies Sales (M) Sdn Bhd, Straits Scientific (M) Sdn Bhd, and Becton Dickinson Sdn Bhd.

2.3 MACB Webinars

In addition to the two conferences, the Scientific and Education Committees jointly organised four webinars on the following topics:

2.3.1 <u>Method Verification on 5 May 2021</u>

The lecture was delivered by Dr. Joshua Hayden, PhD DABCC FAACC, Chief of Chemistry for Norton Healthcare. This is a very useful webinar which discussed the practical approaches that laboratories can take to ensure adequate assessment of new methods. Particular emphasis was given on examples of problems that laboratories might encounter during method validation and how to address them. The webinar was supported by Medinics. A total of 631 participants registered for the webinar of which 350 attended the live event. Of the total participants, 64% were Malaysians. Other participants who registered were from Philippines, Macau, Singapore, United States, Sri Lanka, Pakistan, Oman, Indonesia, India and Bangladesh. 2.3.2 Breathing Not Properly: Heart Failure – Insights on Natriuretic Peptides on 6 May 2021

The lecture was delivered by Dr Pearline Teo, the Clinical Marketing Manager for Laboratory Diagnostics at Siemens Healthineers. The webinar presented the ppathophysiology, diagnosis and classification of heart failure and the importance of Natriuretic Peptides (BNP and NT-proBNP) in the diagnosis, prognosis and management of Heart Failure. The best practice sharing from AP region on the clinical utility of Natriuretic Peptide assays in Asia Pacific was also discussed. This webinar was supported by Siemens Healthineers and received 175 registrations and 69 attendees. 2.3.3 <u>A Practical and Standardized Approach to tackle Reagent Lot-to-Lot using CLSI's EP26 on</u> <u>5 Aug 2021</u>

This lecture was delivered by Mr Norizhar bin Mohamed Zakaria, the Clinical Quality Manager at Siemens Healthineers. This lecture presented the utilization of a standardized and practical approach to document and evaluate reagent lot to lot difference with CLSI's EP26. It discussed the possible scenarios that may arise when evaluating or performing lot to lot differences using EP26's protocol and actions that can be taken. The webinar was supported by Siemens Healthineers and had 364 registered participants with 202 atendees for the live event.

2.3.4 <u>Chemical Screening of Urine by Reagent Strip on 10 Aug 2021</u>

The lecture was delivered by Associate Prof. Dr. Pavai Sthaneshwar, Chemical Pathologist in Pathology Department, University Malaya. The lecture emphasised on the correct urinalysis testing procedure and

guidelines to ensure correct patient results. This webinar was supported by Siemens Healthineers. A total of 512 participants registered for the event with 198 live attendees.

2.5 17th APFCB Congress

Due to the Covid-19 pandemic, international conferences intended for 2020 have been re-scheduled to a later date. This re-scheduling has affected the IFCC 24TH International Congress of Clinical Chemistry and Laboratory Medicine Conference in Seoul, Korea which has now been moved to 26-30 June 2022. Due to this re-scheduling, the 16th APFCB Congress of Clinical Biochemistry due to be held in Sydney in 2022 will now be co-jointly organised with the IFCC 24th International Congress in Seoul, Korea in 2022. With this change in venue, the next APFCB Congress has been moved to 2024 and will be held in Sydney, Australia. The 18th APFCB Congress in Kuala Lumpur will now be in 2026.

2.6 MACB Chronic Kidney Disease Task Force (by Sivasangkari a/p Supremaniam)

The MACB CKD Task Force formed in the year 2017 to look into the national standardization of eGFR estimation in Malaysia. The first meeting was held on 9th December 2017, chaired by Dr. Leslie Charles Lai and committee members as per below:-

In working towards the standardization of eGFR in Malaysia, the MACB carried out a 3 months national survey to determine how eGFR and urine albumin/protein are reported by laboratories in Malaysia. Upon completion of this survey, the committee came up with recommendations and was presented during 28th MACB Conference 2018 in Kuala Lumpur. The recommendations were well received by the audience. An article titled 'A national audit of estimated glomerular filtration rate and proteinuria and the MACB CKD Task Force recommendations' was published in Malaysian Journal of Pathology in April 2021.

The Task Force led by Assoc Prof Dr Pavai conducted a national re-audit in 2021 to update the current findings and to look at the changes in current practices. A proposal has been sent to National Chemical Pathology committee, Ministry of Health to adopt the recommendations nationwide.

2.7 Research Collaboration

The MACB coordinated a research project in 2020 that was completed in 2021. The project was a collaboration between Hospital Canselor Tunku Muhriz UKM (HCTM UKM), Malaysian Association Clinical Biochemist (MACB) and Shenzhen New Industries Biomedical Engineering Co., Ltd. (SNIBE). The project involved method evaluation for Thyroid Stimulating Hormone (TSH), Procalcitonin (PCT) and Heart Fatty Acid Binding Protein (HFABP) diagnostic kits on Maglumi 1000 analyzer.

3.0 EDUCATION SUBCOMMITTEE REPORT

(by Y.M. Tunku Marinah, Chairman of Education Subcommittee)

3.1 Skills Training for Clinical Biochemists

The Working Committee for NOSS headed by Rusli Ibrahim was not able to get much information from the various committees as most of the Chairs and committee members of these committees were busy with online teaching and exams brought about by the MCO and the pandemic.

The MACB Council and the Education Subcommittee need to work out the future direction on this as we have lost focus and realise that it is a very big undertaking to provide skills training for all biochemists. There was a suggestion that perhaps an outside organisation could take this up on behalf of MACB.

Previously arrangement for the syllabus, exams and appointment of trainers and coaches have been done but will need to be revisited before any implementation of the project. For example the appointment of Dr. Shafini as Pengurus for HKL (not gone for induction training yet) and Penyelaras for HKL Puan Siti Gayah (who passed away recently) need to be reviewed.

3.2 Workshop and Webinars

Due to strict SOP's during this pandemic, only webinars were held. A few companies offered and supported webinars for our members as joint activities with Scientific subcommittees.

4.0 CORPORATE AFFAIR SUBCOMMITTEE REPORT

Corporate sub-committee was formed to facilitate scientific and educational collaboration between MACB and the diagnostic industry. Its members consist of MACB members and representative from the industry.

We also help to identify collaboration opportunities with the industry, facilitate discussions on collaborative activities between the association and the industry and finally provide opportunity for industry to give input on the practice of clinical biochemistry with the advancements in science and technology.

This sub-committee is headed by Mrs. Sivasangkari Supremaniam as the Chair. Secretary is Ms Wai San Shen (Roche Diagnostics) and Mr. Adam Hathsey Bronson (Pantai Premier Pathology) as the treasurer.

The Awards subcommittee mission statement is to identify and facilitate receipt of awards by deserving candidates in Clinical Biochemistry.

MACB councils had agreed with the awards proposed that were Young Scientist Awards and MACB Excellent Service Awards. The committees are preparing its guidelines which will detail out the objectives, criteria or eligibility conditions, terms of reference and awards evaluation guidelines. The Awards reviewers had been selected and invited to review this guideline. These reviewers consist of independent representatives from the health industry, corporate, educator, researcher and laboratory medicine background.
