1.0 Opening of Meeting and President's Address

6.0 Appointment of Auditors for the Current Financial Year 2022

7.0 Resolution of Constitution Amendments

The Vice President, Tunku Marinah raised some resolution for amendments to clauses 1.2, 4.2, 4.3, 6.3, 9.2, 9.4 and 10.1 and additions to clauses 6.12 and 10.3 and communicated these points to all members. Here are some of the new points to take note

- a) Amendment to the MACB office address
- b) Annual subscription shall be payable by 15th of Feb of each calendar year
- c) After 15th of Feb, member shall be denied their membership privilege
- d) AGM is allowed to be held virtually
- e) All notices, agenda, minutes, reports, audited accounts, nominations and balloting may be sent or received by mail or electronic media
- f) Increment of petty cash to RM1500. Any excess of this amount shall deposited in a

- bank approved by the Council within seven days
- g) Expenditure exceeding RM5,000 at one time with Council's approval.
 - h) Expenditure exceeding RM50,000 at one time with General Meeting approval.
 - i) The President, Secretary or Treasurer can incur any expenditure less than RM5,000.
 - j) Two persons or more (not MACB Council) shall be appointed as Honorary Auditors for the current year account during MACB AGM. They shall not be reappointed the next subsequent year.

The vice president of the MACB further informed all members that

- a) No Life Membership admission since 1.1.2016
- b) Members with outstanding fees of more than 2 years shall cease to be a MACB member and the Council may take legal action against them, provided that they have received the outstanding notice.

MACB CONSTITUTION AMENDMENTS 2022**A. RESOLUTION****Clause 1**

- 1.2 Its registered place of business shall be Division of Biochemistry, Institute for Medical Research, Jalan Pahang, 50588 Kuala Lumpur or at such other place or places as may from time to time be decided on by the Council. The registered place of business of the Association shall not be changed without the prior approval of the Registrar of Societies.

Amendment

Its registered place of business shall be MACB Office at No 17-07, Tingkat 17, Menara Arina Uniti, No 97, Jalan Raja Muda Abd Aziz, Kampong Baru, 50300 Kuala Lumpur or at such other place or places as may from time to time be decided on by the Council. The registered place of business of the Association shall not be changed without the prior approval of the Registrar of Societies.

Clause 4

- 4.2 Each member shall, upon admission pay the admission fee and the full year's subscription (if required), and thereafter the same annual subscription shall be payable to the Treasurer in advance before the 15th of January.

Amendment

Each member shall, upon admission pay the admission fee and the full year's subscription (if required), and thereafter the same annual subscription shall be payable to the Treasurer in advance before the 15th of February.

- 4.3 Any member who allows his arrears to exceed one calendars year's subscription shall receive a written notification signed by or on behalf of the Secretary, and shall be denied the privileges of membership until he settles his account.

Amendment

Any member who allows his arrears to exceed 15th February of each year shall receive a written notification signed by or on behalf of the Secretary by mail or electronic mail, and shall be denied the privileges of membership until he settles his account.

Clause 6

- 6.3 An Annual General Meeting of the Association shall be held as soon as possible after the close of each financial year but not later than 31st March on a date and at a time and place to be decided by the Council. The business of the Annual General Meeting shall be: -

Amendment

An Annual General Meeting of the Association shall be convened by the Council once a year as soon as practicable after the close of the financial year on a date and at a time and place to be decided by the Council. The Annual General Meeting may be held virtually if decided so by the Council.

To add

- 6.12 All notices, agenda, minutes, reports, audited accounts, nominations and balloting may be sent or received by mail or electronic media. If given by electronic media, it shall be deemed to be delivered when it is tagged sent by the software.

Clause 9

9.2 The Treasurer may hold a petty cash advance not exceeding one thousand ringgit at any one time. All money in excess of this sum shall within seven days of receipt be deposited in a bank approved by the Council. The bank account shall be in the name of the Association.

Amendment

The Treasurer may hold a petty cash advance not exceeding one thousand and five hundred ringgit at any one time. All money in excess of this sum shall within seven days of receipt be deposited in a bank approved by the Council. The bank account shall be in the name of the Association.

9.4 No expenditure exceeding five thousand ringgit at any one time shall be incurred without the prior sanction of the Council and no expenditure exceeding fifty thousand ringgit in any one month shall be incurred without the prior sanction of a general meeting. Expenditure less than five thousand ringgit may be incurred by the President together with the Secretary or the Treasurer.

Amendment

No expenditure exceeding five thousand ringgit at any one time shall be incurred without the prior sanction of the Council and no expenditure exceeding fifty thousand ringgit in 14 days in any one month shall be incurred without the prior sanction of a general meeting. Expenditure less than five thousand ringgit may be incurred by the President together with the Secretary or the Treasurer.

Clause 10

10.1 One person or more, who shall not be office bearers of the Association shall be appointed by the annual general meeting as Honorary Auditors. He/they shall hold office for one year only and shall not be reappointed the next subsequent year.

Amendment

Two persons or more, who shall not be office bearers of the Association shall be appointed by the annual general meeting as Honorary Auditors. He/they shall hold office for one year only and shall not be reappointed the next subsequent year.

To add

10.3 External certified/licensed auditors may be appointed by the council.

Others

Language: to change to English (in ROS system)

B. REMINDER

Clause 3

3.2 There shall be the following classes of membership of the Association, namely:

- Fellow
- Ordinary Member
- Associate Member
- Honorary Fellow
- Corporate Member
- Life Member (not available from 1.1.2016)
- Retired Member

- 3.2.6 “Life Member” shall be such person as comply with the requirement of paragraph 3.1 hereof, who has been an “Ordinary Member” for a minimum of five years and has applied for life membership by submitting the required subscription fee, subject to approval by the Council.

The admission of new “Life Members” will cease with effect from 1.1.2016. However, existing “Life Members” will continue to be entitled to all benefits and privileges of membership as before.

- 3.3 A Fellow, Ordinary Member, Associate Member or Life Member who ceases to be wholly or mainly occupied in the practice of clinical biochemistry shall not by reason thereof cease to be a Life Fellow, Ordinary Member, Associate Member or Life Member unless the Council so decides.
- 3.6 Upon the admission of a person as a Fellow, an Ordinary Member, a Life Member or a Retired Member, he shall become entitled to all the benefits and privileges of membership of the Association and subject to all the obligations thereof and shall be bound by the provisions of this Constitution.

Clause 4

- 4.4 Any member who allows his arrears to exceed two calendar year’s subscription shall automatically cease to be a member of the Association, and the Council may direct that legal action be taken against him, provided that they are satisfied that he has received due notice of his debts.
- 4.7 Paragraphs 4.3, 4.4 and 4.5 shall not apply to Life, Honorary Fellow or Retired Members.
